2. Unit aims and outline

In this unit you will gain practical work-based experience working with a range of patients and clients, building upon your experience in the PHY601 Physiotherapy Practice 1 unit. You will have the opportunity to apply your theoretical knowledge and skills that have been developed while studying other units on this course, applying them in practical environments and utilising your transferable skills. This practical placement unit is composed of two 7-week placements focused on a specific area of physiotherapy practice. These may include care of the elderly, neurology, orthopaedics, respiratory medicine, outpatients, amputees, obstetrics and gynaecology, musculoskeletal, oncology, palliative care, paediatric or community contexts.

3. Intended Learning outcomes

Having completed this unit, you will be able to:

- (a) Demonstrate the ability to apply a reasoned problem-solving approach to patient care, integrating underpinning theory and previous experience to justify decisions made.
- (b) Critically evaluate a range of possible interventions and the ability to respond to changing contexts.
- (c) Prioritise problems, set goals and plan an appropriate treatment programme in consultation with patients / clients.
- (d) Demonstrate evidence of engaging in interprofessional learning, whilst on placement.
- (e) Demonstrate a commitment to continued professional development, planning and reflective practice.

3. Intended Learning outcomes

(f) Critically appraise the range of therapeutic interventions to implement a management programme safely, effectively and efficiently.

4. Indicative content

- Integrating health and safety legislation into physiotherapy practice
- Fulfilling all responsibilities related to legal ethical and local considerations of professional practice including clinical information (CSP, 2011; HCPC, 2016)
- Establishing a therapeutic relationship, demonstrating sensitivity to the needs of others, having an awareness of physical, psychosocial and cultural needs
- Establishing appropriate relationships within a team, i.e. health and social care staff and students
- Communicating in a professional manner with different stakeholder groups including: patients/clients, relatives, carers and colleagues using; verbal, non-verbal, listening, writing skills
- Reflective practice
- Accountability and knowledge of own professional and personal scope of practice; whilst recognising and acknowledging the contributions of team members
- Applying appropriate assessment and treatment strategies, safely and effectively
- Decision-making in relation to patient/client management using evidence-based practice
- Monitoring and reviewing the ongoing effectiveness of planned activity, recognising the need to modify management in conjunction with patients/clients or carers
- Ensuring the patient/client is central in the management of their health and wellbeing
- Demonstrating an awareness of a holistic process of enquiry by undertaking physiotherapy assessment strategies which are appropriate for the patient
- Recognising and interpreting clinical features to formulate a problem list using the findings from the patient assessment
- SMART goal setting and motivation
- Planning individualised treatment/management programmes considering available resources
- Selecting and interpreting appropriate measures to evaluate the outcome of physiotherapy interventions
- Gathering data (qualitative and quantitative), evaluating service provision
- Audit, quality management and quality control
- Making and receiving referrals
- Personal workload, health and wellbeing management
- Interprofessional learning

5. Indicative summary of teaching and learning methods and activities including contact hours

The unit will be predominantly placement based with tutorial support. Learning will be encouraged through student centred activities including online materials, directed learning and experiential reflects.

Indicative assessment

In the first assessment you will complete two 4000-word equivalent practice placement portfolios (one for placement 3 and one for placement 4) that will include a placement report by the Practice Placement Educator from each of the two placements undertaken. For the second assessment you will complete a 2000 word Continuing Professional Development (CPD) e-portfolio, one at the end of each placement. This will consist of a range of relevant planning and reflective tasks. In order to pass the unit you are required to pass both elements of assessment.

Indicative feedback methods

For formative tasks you will receive verbal feedback from peers as part of a 'peer review' process for the CPD e-portfolio and the Practice Placement Educators for the Practice Placement e-Portfolio. Feedback on the final summative tasks will be written and returned electronically to you.
